Presidents' & Executive Director's Report

2019 was a year of transition for us, as individuals, and for ECAO. The year began with Mark as President, and finished with Brad at the helm. This was a very smooth, almost seamless, transition for the three of us; however it was a transition nonetheless. ECAO moved, just as seamlessly, from surveying our community to engaging in action to advance our association and partners. Throughout the transition, though, we continued to work hard to fully represent our members, labour partners, and affiliates both within and outside our industry. We are pleased, and proud, to provide an overview of some of these activities in this Annual Report.

On behalf of ECAO we continued, as the year began, to build our community; affiliate partners, industry partners, government, associations, and others. Our participation on industry committees, appearances before government officials and ministers (and, at their events), community

outreach, and social media engagement all increased. Further, our Executive, Board, and members all answered the call providing us with varied industry interests and geographic area involvement in our efforts. Perhaps most notable was the increasing evolution and enhancement of the relationship between ECAO and IBEW/CCO, even in a bargaining year. It was our goal, and we believe we are well on our way in this regard, to move from a relationship of cooperation to one of collaboration. In fact, it is in this manner that we want to engage all of our partners.

In regard to negotiations, which occurred in late 2018 and early 2019, ECAO and IBEW/CCO set the standard for the construction industry in the Province of Ontario. We were first to settle and we did so under a mechanism that had not been seen previously. As Jodi writes in greater detail on the negotiations herein, we are not going to delve into the experience other than to tell you that we are proud of the new mechanism of using mediators at the local and provincial level to bring the parties together to focus on goals, rather than to emphasize differences. We want to thank everyone for their willingness to attempt a new approach and for their dedication to the process of getting a fair deal for ECAO members.

All of you are, no doubt, aware of the winding down of the Ontario College of Trades (OCoT) as legislated by the Provincial Government in their spring budget. The potential void left with the impending exit of OCoT and the suggestion by the government that there may be a move to skill-sets, rather than trades, had us very concerned about the integrity of our electrical trades. As a result, we worked with IBEW/CCO, the Ontario Electrical League (OEL), and the Christian Labour Association of Canada (CLAC) to present submissions to the (then) Minister of Labour and Minister of Trades, Colleges and Universities regarding the importance in terms of safety, skills, and efficiency of maintaining our trades' integrity. This was an unprecedented alliance representing the vast majority of the legitimate players in our electrical construction and maintenance industry. And, that the four organizations could come together to produce joint submissions, as well as appear together in person, was noticed industry-wide. More importantly, however, the effect of joint submissions and appearances clearly demonstrated to the decision-makers that there is a need to carefully listen to, and heed, industry stakeholders prior to making changes. Increased engagement of our members and partners with the Provincial Government was also a key factor in our progress to date.

Among the myriad of activities in 2019, there were four (4) undertakings that we feel deserve special mention:

Annual Conference in Nashville, Tennessee. ECAO, through our event planners, Cubed Inc., responded to the challenges of continuous improvement, an outstanding venue, and providing something for all attendees. Music City did not disappoint! The opportunities to network, the group events, and the venue were all given rave reviews. In addition to our regular business sessions, we also provided attendees the opportunity to visit a local contractor's facility which included a prefabrication operation and the local union's training facility. Learning from others in our industry was, we felt, a great way to be educated in a more hands-on fashion.

Government Relations. As alluded to above, this is an area in which ECAO made great strides in 2019. Our approach has been to assist the government, and opposition, in learning about our industry and our community. It is beyond debate that there has long-been a fundamental lack of knowledge about the construction industry by decision-makers in governments; all levels of government. ECAO, along with our labour partners and our lobbying firm, Rubicon, is working diligently to educate ministers and their staffs. Ministers with whom we have met have included: Labour, Skills and Training; Training, Colleges and Universities; Attorney General; and the Premier's Office. Your Executive and Board also joined us at numerous other gatherings that also gave us a chance to meet with ministers and their staffs.

Annual General Meeting (AGM). For the second consecutive year we made a significant change to the AGM, adding the Joint Electrical Promotion Plan (JEPP) AGM to the ECAO event. The goal was to encourage greater attendance at both of the AGM meetings and the "gala" event. Not only were we very successful in having more attendees, we also saw attendees embrace our themed event, the Great Gatsby, more fervently than last year. It is our intent to continue to build on this event.

Communications and Education. Our community has really responded to our challenge to become more involved in social media, as you will see from our report later herein. Aside from the social media uptake, we also continued the development of our website, collaboration with JEPP, IBEW/CCO and Powering Communities websites, our E-News, and the local ECA Newsletter. Further, 2019 saw us launch more regular communications with local ECAs which included a Day at the Races, in person meetings, and conference calls. It is critical, in our view, that communication with our ECAs be open and frequent. Frequent was also the "theme" for our education programs in 2019. However, frequency was not obtained at the expense of quality. Seminars, webinars, and training sessions included an increased number hosted and/or presented by our Affiliate Partners in 2019; a trend that we plan on maintaining.

We continue to relish in the opportunity to represent you, our members and partners, and to further the interests of our community! It is our shared view that ECAO is trending upwards; we are no longer a secret within our industry. Your views, your interests, your needs are being effectively conveyed and are being done so with passion, pride, and professionalism. Thank you for your support, ideas, engagement, and the confidence you have placed in us.





LABOUR RELATIONS REPORT

Early 2019 was spent in negotiations with our labour partners, IBEW/CCO. Local negotiations began in late 2018 with eight of the eleven areas utilizing the services of an independent mediator. Mediators were introduced as an option to all areas for the first time this round, with the goal of assisting with progressive discussions to move our industry forward. Some areas saw success in their local negotiations with meaningful language changes, including small project agreements. If utilized, these changes will contribute to the competitiveness of our contractors and potentially increase our footprint in the industry.

Provincially, we were able to reach an agreement on wage increases over the next three years without proceeding to Final Offer Selection. Final Offer Selection is a process under our Joint Proposal whereby an arbitrator chooses either ETBA's final wage offer or IBEW's final wage offer; whichever is the most reasonable. Under our Joint Proposal, Final Offer Selection does not consider language changes or the lack thereof. Also, our Joint Proposal outlined an agreement on a post-negotiation wage adjustment (PNWA) to a maximum amount of \$1.00, if any of the eight comparator trades negotiated a higher wage increase. Late 2019, the IBEW agreed with ETBA's position that the PNWA would be seventeen cents, based on the increases negotiated by the Mechanical (Plumbers and Pipe Fitters) and Operating Engineer bargaining agents. This increase will apply in May 2020 (9 cents) and May 2021 (8 cents).

While we were optimistic that this round of bargaining would result in more meaningful language changes, locally and provincially, we are pleased with the outcome of local bargaining and believe our relationship with the IBEW/CCO will continue to strengthen over the next few years. We do not want to wait until May 2022 for additional discussions and changes to occur, and the ETBA, along with the Line and Communications committees, will continue to strive to make improvements to the agreements. Our goal is to make ECAO contractors more competitive, which will increase the use of our members and increase our market share. Also, we encourage local areas to have frank discussions and work together to grow their markets. We believe that our labour partners are now, after bargaining, more open to assisting us in achieving this goal.

At the ECAO Industry Conference in Nashville, we had the opportunity to hear from David Long, Chief Executive Officer of NECA, and Lonnie Stephenson, International President of the IBEW. In a town hall meeting format, they discussed how they have been moving their partnership from one of cooperation to collaboration. NECA's goal is to increase market share by 10% by 2025 and IBEW's goal is to increase membership numbers. They both know they need to be price competitive, productive and efficient, while finding ways to add value and attract new talent. They have a shared goal of having IBEW members and NECA contractors on every job site.

Lonnie and David talked about the successes they've seen with the Construction Electrician and Construction Wireman classifications, which were jointly developed by IBEW and NECA; and launched in Florida in 2005 to help Electrical Contractors become more competitive. When utilized, the classifications have helped all parties in the US gain new employees, members and increased market share. NECA contractors have also brought their IBEW partners into the bidding process, to help them get to a lower composite rate. They talked about the importance of pre-fabrication, especially since competitors are using it to be more productive on job sites. Many attendees in Nashville took advantage of that area's electrical industry's graciousness to attend a tour of a local contractor facility with a prefab operation, and a training centre.

In my view, the United States have generally been 10-15 years ahead of Canada with respect to language changes, new classifications, and collaborative goal setting. It's time for us to learn from their successes and failures and implement things that could work for us here in Ontario.

We've been continuing to build our relationship with our labour partners; the IBEW/CCO. Several IBEW Business Managers attended our Industry conference in Nashville and our members had opportunities to interact on a much more informal and effective manner, share concerns and ideas, as well as simply strengthen relationships with the Business Managers and IBEW/CCO Officers. We've also recently seen changes at the IBEW/CCO office, with the retirement of John Grimshaw. James Barry has taken over management of the IBEW/CCO and recently announced the hiring of Mark Watson as his Executive Assistant. Mark Watson, most recently the Business Manager in Local 804, was instrumental in contributing to positive changes within their local agreement during the last round of bargaining.

ETBA saw a change in their Chair and Vice Chair at the ECAO AGM in October. Chris Cimek, was the ETBA Chair for the past three years and made a decision to step down at our 2019 AGM. Terry Moore, previous ETBA Vice Chair, became our new ETBA Chair, and Dan Camilleri is the new Vice Chair. On behalf of ECAO and ETBA, we would like to thank these individuals for their time and commitment to improving our industry. Their knowledge of the industry and willingness to provide practical and useful guidance is much appreciated and valued.

Moving forward, we are hopeful that all parties will be open to learning what other areas have done to improve the market share within the unionized electrical industry and apply it, with any necessary modifications, to our circumstances. There is little sense in re-inventing the wheel. We spent considerable time in 2019 investigating what works in other jurisdictions, an exercise we will continue. Now, it is time to implement.



- Supported visits by Minister to various IBEW training centres.
- Building partnership with Chamber of Commerce to have voice in policy papers submitted to government.

Local initiatives

- Facilitated a grant of \$80,000 to create a marketing campaign to highlight the high level of training provided by the IBEW/ECAO to ensure safety and professionalism.
- Created backdrop and pamphlet for trade show.
- Provided funding to Sarnia Local to support initiative with Scouts Canada, highlighting our commitment to give back to communities.
- Provided funding to Ottawa for radio commercial to highlight benefits of apprenticeship with IBEW/ECAO team.

GOVERNMENT RELATIONS UPDATE

In mid-2019, Premier Doug Ford sought to 'reset' his Progressive Conservative Government with near whole-scale Cabinet shuffle. As it is related to the labour file,



the goal was to build a better relationship with the construction trade unions. New Ministers who were more sympathetic to construction unions were brought in for Labour as well as Training, Colleges and Universities (MTCU).

After a few months, one of those Ministers performed exceedingly well at fostering a better relationship with the construction unions. As a result, the 'training' functions from MTCU were transferred to the Labour Minister, making Monte McNaughton the most powerful Ontario Labour Minister, in terms of authorities, in over 40 years. Since his appointment, McNaughton has launched an endless personal campaign to meet and listen to every labour group in the province – which has been widely applauded by the sector.

CERTI-FIRE UPDATE

With tremendous support from the Joint Electrical Promotion Plan (JEPP), the Certi-Fire Fire Alarm & Protection Certification Program has become increasingly significant and is enlarging its footprint in the fire alarm industry. With this in mind Certi-Fire launched a new website in 2019 to elevate the presence of the Certi-Fire Program.

In accordance with Ontario Fire Marshal endorsement, Certi-Fire upgrades and improves the skills of Electricians in order to enhance their employability and to provide training to adapt to technological and code changes in Fire Alarm & Protection Systems. Certi-Fire electricians will be qualified to do verification, annual testing, inspection, maintenance, and installation under non-Building Permit or Retrofit situations with respect to Fire Alarm & Protection Systems.
